Methods for cleaning up

Dam up. Keep in suitable, closed containers for disposal. Soak up with inert absorbent material. Contain spillage, and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations (see section 13). Use mechanical means such as pumps, skimmers and absorbent materials.
